**INTRODUCTION**

The purpose of this document is to provide you with information regarding the resolutions to be proposed at the AGM involving (1) the re-election of retiring Directors and (2) the grant to the Directors general mandates to allot, issue and deal with additional Shares and to repurchase Shares, and the extension of the general mandate to allot, issue and deal with new Shares by the addition thereto of any Shares repurchased by the Company.

### (1) RE-ELECTION OF RETIRING DIRECTORS

In accordance with article no. 87 of the Articles, Ms. Chou Chiu Yueh, Ms. Lin I Chu and Ms. Liu Fang Chun will retire by rotation at the AGM and, being eligible, have offered themselves for re-election.

#### **Recommendations of the Nomination Committee**

In accordance with the terms of reference of the nomination committee of the Company (the “Nomination Committee”), the Nomination Committee has evaluated the performance and the contribution of each of the retiring Directors, namely Ms. Chou Chiu Yueh, Ms. Lin I Chu and Ms. Liu Fang Chun during the last financial year of the Company and the period thereafter up to the date of evaluation.

The Nomination Committee is of the opinion that the performance of each of Ms. Chou Chiu Yueh, Ms. Lin I Chu and Ms. Liu Fang Chun was satisfactory.

Accordingly, the Nomination Committee recommended to the Board to propose to re-elect Ms. Chou Chiu Yueh and Ms. Lin I Chu as executive Directors and Ms. Liu Fang Chun as a non-executive Director.

The qualifications, previous experience and major appointments of all the Directors who stand for re-election at the AGM are set out in the “Directors and Senior Management Profiles” section contained in the 2018 Annual Report which has been sent to the Shareholders together with this document. The other biographical details of each of the retiring Directors, as required to be disclosed pursuant to rule 13.51(2) of the Listing Rules, are set out below for the Shareholders’ consideration.

#### **1. Chou Chiu Yueh (aged 66)**

Ms. Chou is the vice-president of the Group. She has been a Director since 14 December 2005 and is also a director of various subsidiaries of the Company. She is also a member of the Nomination Committee and the remuneration committee of the Company (the “Remuneration Committee”). Ms. Chou did not hold any directorship in other listed companies in the last three years.

Ms. Chou is the spouse of Mr. Lin Chin Tsun (an executive Director and the chairman and president of the Group) and the mother of Mr. Lin Yuan Yu (an executive Director and chief executive officer of the Group) and Ms. Lin I Chu (an executive Director) and the mother-in-law of Ms. Liu Fang Chun (a non-executive Director). Ms. Chou Chiu Yueh is a director of VMHL, a substantial Shareholder. Save as disclosed, Ms. Chou does not have any relationship with any other Directors, senior management or substantial or controlling Shareholders.

As at the Latest Practicable Date and within the meaning of Part XV of the SFO, Ms. Chou was deemed to be interested in an aggregate of 564,973,947 Shares. Out of these Shares, 67,955,786 Shares were beneficially held by Ms. Chou, 395,360,783 Shares were held through companies controlled by Ms. Chou and 101,657,378 Shares were held by her spouse.

Ms. Chou entered into a service agreement with the Company for a term of three years commencing from 7 May 2016. Ms. Chou's annual remuneration, as covered by her service agreement, is currently HK\$1,300,000 and NT\$1,300,000. Pursuant to Ms. Chou's service agreement, she is entitled to a discretionary bonus as determined by the Remuneration Committee provided that the total amount of bonuses payable to all the executive Directors in any year shall not exceed 5% of the audited consolidated profit after taxation and minority interests but before extraordinary items of the Group (if any) for the relevant year.

### **2. Lin I Chu (aged 39)**

Ms. Lin has been a Director since 3 April 2007 and is currently an executive Director. She is also a director of various subsidiaries of the Company. Ms. Lin did not hold any directorship in other listed companies in the last three years.

Ms. Lin is the daughter of Mr. Lin Chin Tsun and Ms. Chou Chiu Yueh (executive Directors and respectively the chairman and president and the vice-president of the Group) and the sister of Mr. Lin Yuan Yu (an executive Director and chief executive officer of the Group) and the sister-in-law of Ms. Liu Fang Chun (a non-executive Director). Save as disclosed, Ms. Lin does not have any relationship with any other Directors, senior management or substantial or controlling Shareholders.

As at the Latest Practicable Date and within the meaning of Part XV of the SFO, Ms. Lin had or was taken or deemed to have interest in an aggregate of 384,014,783 Shares. Out of these Shares, 9,429,777 Shares were beneficially held by Ms. Lin, 374,585,006 Shares were held through a company controlled by Ms. Lin.

Ms. Lin entered into a service agreement with the Company for a term of three years commencing from 1 September 2017. Ms. Lin's annual remuneration, as covered by her service agreement, is currently HK\$1,040,000, NT\$1,950,000 and RMB260,000. Pursuant to Ms. Lin's service agreement, she is entitled to a discretionary bonus as determined by the Remuneration Committee provided that the total amount of bonuses payable to all the executive Directors in any year shall not exceed 5% of the audited consolidated profit after taxation and minority interests but before extraordinary items of the Group (if any) for the relevant year.

### **3. Liu Fang Chun (aged 40)**

Ms. Liu has been a Director since 3 April 2007 and is currently a non-executive Director and assistant of the chairman of Capxon Yichang. Ms. Liu did not hold any directorship in other listed companies in the last three years.

Ms. Liu is the spouse of Mr. Lin Yuan Yu (an executive Director and chief executive officer of the Group) and the daughter-in-law of Mr. Lin Chin Tsun (the chairman and president of the Group) and Ms. Chou Chiu Yueh (an executive Director and vice-president of the Group) and the sister-in-law of Ms. Lin I Chu (an executive Director). Save as disclosed, Ms. Liu does not have any relationship with any other Directors, senior management or substantial or controlling Shareholders.

As at the Latest Practicable Date and within the meaning of Part XV of the SFO, Ms. Liu was deemed to be interested in an aggregate of 394,675,621 Shares. Out of these Shares, 6,928,993 Shares were beneficially held by Ms. Liu and 387,746,628 Shares were held by her spouse.

Ms. Liu entered into an appointment letter with the Company for a term of three years commencing from 7 May 2016. Ms. Liu's annual remuneration, as covered by her appointment letter, is currently HK\$650,000 and NT\$650,000. Ms. Liu is also entitled to such bonus as may be determined by the Board based on the recommendation of the Remuneration Committee from time to time.

#### **4. Additional Information**

- (i) The emoluments of all Directors are determined on the basis of the relevant Director's experience, level of responsibilities within the Group and the current market situation.
- (ii) Save for the information set out in this section and in the 2018 Annual Report, there is no other matter that needs to be brought to the attention of the Shareholders and there is no other information which is required to be disclosed under paragraphs (h) to (v) of rule 13.51(2) of the Listing Rules.

#### **(2) GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES**

As the general mandates granted to the Directors to allot, issue, and deal with and repurchase Shares respectively pursuant to resolutions passed by the Shareholders at the Company's annual general meeting held on 31 May 2018 will lapse at the conclusion of the AGM, resolutions will be proposed at the AGM to renew the grant of these general mandates. The relevant resolutions, in summary, are:

- an ordinary resolution to grant to the Directors a general and unconditional mandate to allot, issue, and deal with additional securities of the Company (including, inter alia, offers, agreements, options, warrants or similar rights in respect thereof) not exceeding 20% of the number of the Company's issued shares as at the date of passing the relevant resolution for the period from the close of the AGM until the conclusion of the next annual general meeting of the Company (or such earlier period as stated in the resolution) (the "Issue Mandate");

- an ordinary resolution to grant to the Directors a general and unconditional mandate to exercise all the powers of the Company to repurchase such number of Shares not exceeding 10% of the number of the Company's issued shares as at the date of passing the relevant resolution for the period from the close of the AGM until the conclusion of the next annual general meeting of the Company (or such earlier period as stated in the resolution) (the "Repurchase Mandate"); and
- conditional on the passing of the resolutions to grant the Issue Mandate and the Repurchase Mandate, an ordinary resolution to authorize the Directors to exercise the powers of the Company to allot, issue, and deal with additional securities under the Issue Mandate by adding those Shares repurchased by the Company pursuant to the Repurchase Mandate.

The explanatory statement providing the requisite information regarding the Repurchase Mandate as required to be sent to Shareholders under the Listing Rules is set out in Appendix I to this document.

### **(3) AGM**

The notice convening the AGM is set out in Appendix II to this document. At the AGM, amongst others, ordinary resolutions will be proposed to approve the re-election of the retiring Directors, the granting of the Issue Mandate and the Repurchase Mandate and the extension of the Issue Mandate by the addition thereto of any Shares repurchased under the Repurchase Mandate.

A form of proxy for use at the AGM is enclosed with this document. Whether or not you intend to attend the AGM, you are requested to complete and return the form of proxy in accordance with the instructions printed thereon to the Company's branch share registrar and transfer office in Hong Kong, Tricor Investor Services Limited, Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong as soon as possible and in any event no later than 2:30 p.m. on 2 June 2019 (Hong Kong time) or not less than 48 hours before the time appointed for holding of the AGM or any adjournment thereof. Completion and return of the form of proxy will not preclude you from attending and voting at the AGM should you so wish.

Pursuant to Rule 13.39(4) of the Listing Rules, any vote of the Shareholders at a general meeting of the Company must be taken by way of a poll. Accordingly, the resolutions to be proposed at the AGM will be voted by way of a poll by the Shareholders.

### (4) RECOMMENDATION

The Directors consider that the proposed resolutions regarding the re-election of the retiring Directors, the granting of the Issue Mandate and the Repurchase Mandate and the extension of the Issue Mandate by the addition thereto of any Shares repurchased under the Repurchase Mandate are in the best interests of the Company and its Shareholders as a whole. Accordingly, the Directors recommend the Shareholders to vote in favour of the proposed resolutions.

## **1.    EXERCISE OF THE REPURCHASE MANDATE**

On the basis of 844,559,841 Shares in issue as at the Latest Practicable Date and assuming no further Shares will be issued or repurchased by the Company before the AGM, exercise in full of the Repurchase Mandate could result in up to 84,455,984 Shares being repurchased by the Company during the period from the date of passing of the resolution relating to the Repurchase Mandate up to the earliest of (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles or any applicable laws to be held; and (iii) the revocation or variation of the Repurchase Mandate by ordinary resolution of the Shareholders in general meeting.

## **2.    REASONS FOR REPURCHASES**

Repurchases of Shares will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders as a whole. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or its earnings per Share.

## **3.    FUNDING OF REPURCHASES**

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its Articles and the applicable laws of the Cayman Islands. Such funds include profits available for distribution.

## **4.    GENERAL**

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the latest published audited accounts as contained in the 2018 Annual Report) in the event that the Repurchase Mandate is exercised in full at any time during the proposed purchase period. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or on the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

## **5.    DIRECTORS AND CORE CONNECTED PERSONS**

As at the Latest Practicable Date, to the best knowledge of the Directors having made all reasonable enquiries, none of the Directors and their respective close associates has a present intention, in the event that the Repurchase Mandate is approved and exercised, to sell Shares to the Company. No core connected persons have notified the Company that they have a present intention to sell Shares to the Company, or have undertaken not to do so, in the event that the Repurchase Mandate is approved and exercised.

**6. UNDERTAKING**

The Directors have undertaken to the Stock Exchange that they will exercise the Repurchase Mandate in accordance with the Listing Rules, the memorandum of association of the Company and the Articles and the applicable laws of the Cayman Islands.

**7. THE HONG KONG CODE ON TAKEOVERS AND MERGERS**

If as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code. As a result, a Shareholder, or a group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase in the Shareholder's interests, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with rule 26 of the Takeovers Code. A waiver of this provision would not normally be given except in extraordinary circumstances. As at the Latest Practicable Date, the following interests in the Shares were recorded in the register kept by the Company pursuant to section 352 of the SFO:

4. To consider and, if thought fit, pass with or without modifications, the following resolutions as ordinary resolutions:
  - 4.A. **“THAT:**
    - (a) subject to paragraph (c) of this resolution, the exercise by the Directors during the Relevant Period (as hereinafter defined) of all the powers of the Company to allot, issue and deal with additional shares in the capital of the Company or securities convertible into such shares or warrants or similar rights to subscribe for any shares in the Company and to make or grant offers, agreements and options which might require the exercise of such power be and is hereby generally and unconditionally approved;

(a) subject to paragraph (b) of this resolution, the exercise by the Directors during the Relevant Period of all the powers of the Company to repurchase its own shares on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) or on any other stock exchange on which the securities of the Company may be listed and recognized by the Securities and Futures Commission and the Stock Exchange for this purpose, subject to and in accordance with all applicable laws and requirements of the Rules Governing the Listing of Securities on the Stock Exchange or of any other stock exchange on which the securities of the Company may be listed as amended from time to time, be and is hereby generally and unconditionally approved;



- (b) the aggregate number of shares of the Company to be repurchased by the Company pursuant to the approval mentioned in paragraph (a) of this resolution during the Relevant Period shall not exceed 10 per cent of the number of issued shares of the Company as at the date of passing of this resolution and the said approval shall be limited accordingly; and
- (c) the expression “Relevant Period” shall for the purposes of this resolution have the same meaning as assigned to it under ordinary resolution 4.A.(d) of this notice.”
- 4.C. “**THAT** conditional upon resolutions 4.A. and 4.B. above being passed, the aggregate number of shares of the Company which are repurchased by the Company under the authority granted to the Directors as mentioned in resolution 4.B. above shall be added to the number of shares that may be allotted or agreed conditionally or unconditionally to be allotted and issued by the Directors pursuant to resolution 4.A., provided that the number of shares repurchased by the Company shall not exceed 10 per cent of the number of issued shares of the Company as at the date of passing of this resolution.”
